I cannot stop or lower my payments even if my financial situation changes.</li> <li>I understand that all the terms and conditions of the original agreement and any supplemental agreements remain in effect.</li> <li>I understand that I may make more than one binding, irrevocable agreement, so long as a subsequent agreement does not amend this binding and irrevocable agreement.</li> <li>I understand that this agreement allows for the deduction from salary for employer pick-up purposes.</li> <li>I understand that for the effective period of this agreement, my employer must make the revised scheduled deduction each pay period. While this agreement is in effect, ORS will only accept payments from my employer.</li> <li>I understand that my employer is obligated to make payment according to this agreement only if there are sufficient funds from my earnings after any other mandatory deductions.</li> <li>I understand that it is my responsibility to ensure that the deduction I agreed to are made as specified in this agreement.
